Mobilities to EMUNI University (Slovenia) in the framework of the European Programme

ERASMUS+ KA1

• Objective :

The Erasmus+ Programme offers to staff the chance to gain cultural experience abroad, to exchange programme and creating possibilities for sharing knowledge and experiences among partner universities.

The prupose of the call is to allow teaching and non-teaching staff from Partner country institutions to conduct training mobility at EMUNI University.

This activity supports the professional development of HEI staff in the form of teaching and training events at a partner HEI abroad.

<u>**1** candidate will be selected</u> among **4** Tunisian partners to benefit from the scholarship : (University of Sfax, University of Tunis, University of Sousse, Virtual University of Tunis)

• Application requirements :

General admission requirements :

- The staff has to be employed /permanent in the Virtual University of Tunis
- To submit a Mobility Agreement proposal, validated at both ends by the relevant academic authorities at the home university.

Fields of training : academic department - financial department

- Mobility agreement

- Motivation letter
- Copy of the passport

The Virual University of Tunis is responsible of selection procedures on the basis transparent and fair criteria.



• Pre-selection criteria:

The home university will provide to EMUNI University a pre-selection of candidates according to the following general criteria:

- Academic background and experience
- Knowledge of English language on B1 Level (online test in english will be passed)
- Preference will be given to staff not having benefitted from mobility under the project KA1 yet/coming from University with fewer mobilities implemented by the past. (mobilities under the project KA1, meaning the staff exchanges for the purpose of training or teaching).
- Mobility period, duration and obligations :

The mobility shall be carried out by latest 31-07-2022

Duration of the mobility : 7 days (5 days training + 2 travel days)

Obligations after Mobility (participant):

- Submission of a publishable travel report to the home University within 2 weeks after the end of the mobility period
- Fill in the participant survey via the Mobility tool+ within 30 days after the end of mobility period
- Provide necessary supporting documents
- Mobility Grant :

Participants are entitleed to receiving financial support in form of a grant which need to be used to cover costs of stay and travel costs which would not have been incurred if participant did not undertake the mobility.

<u>Cost of stay</u> : Including accomodation , local transfer and per diem in line with Slovene legislation : max 140 € per day .

<u>Travel Costs</u> : Travel distance must be calculated using the distance calculator supported by the European Commission (<u>https://erasmus-plus.ec.europa.eu/resources-and-tools/distance-calculator</u>)

The deadline for applying is fixed at 28th November 2021.
